endorsement negotiations and recently worked on a name, image, and likeness deal for him on behalf of the David Duval Golf Center.

An accomplished trial attorney, Alan has tried over 100 jury and non-jury trials. His recent victories include obtaining a jury verdict of not guilty where three other co-defendants were found guilty of \$25 million dollars of damage; obtaining a zero verdict on behalf of the City of Doral; and, on the night before trial, obtaining a rare dismissal of a case in favor of his client the City of Homestead.

An intense negotiator, Alan cites his charismatic personality, persistence, and aggressive litigation skills as the keys to his success. Over the course of his 40-year legal career, Alan has developed the legal skills to handle any case and any client that demands his legal representation. He negotiated the Principal Hosting Agreement for the 2014 Miss Universe Pageant and has negotiated broadcast agreements with the Miami Marlins, Miami Dolphins, Florida Panthers, and the University of Miami Hurricanes. He has acted as counsel to the Miami-Dade Special Olympics, World Series of Boxing, the National Senior Games and the World Water Skiing Championships. Alan has also negotiated endorsement agreements with Speedo, TYR, Omega, Coca-Cola, Comcast, NOBULL, Hershey's, and Toyota, as well as sponsorship agreements with Beats and GrubHub, for his athlete clients.
