

CITY OF HOMESTEAD, FLORIDA EXECUTIVE ORDER AND SUPPLEMENT PURSUANT TO DECLARATION OF STATE OF EMERGENCY

Section 1. Declaration Supplemented and Extended.

In accordance with Section 11-5(e) of the City Code of Ordinances and Chapter 252, Florida Statutes, the Declaration of a State of Emergency within the City of Homestead, Florida, ("City"), dated March 17, 2020 is hereby re-affirmed, remain in full force and effect, and is further supplemented pursuant to this Order.

Section 2. Findings.

- (A) The detailed findings of Governor Desantis' Executive Order Numbers 20-52, 20-68, 20-82, and 20-83 are hereby incorporated herein by reference.
- (B) The detailed findings of Miami-Dade County Mayor Gimenez, as contained in Executive Order Extending Declaration of Local State of Emergency, dated March 25, 2020, is hereby incorporated herein by reference.

Section 3. Order: Curfew.

In order to protect the public health, safety, and welfare, including the mitigation of the spread of the COVID-19 virus, a curfew shall be established within the jurisdictional limits of the City of Homestead. The curfew shall commence March 27, 2020 and continue until further notice between the hours of 10:00 pm and 5:00 am, within the jurisdictional limits of the City of Homestead. No person shall be outside in this area during the curfew hours either as a pedestrian or by means of a vehicle, unless such person is providing police, fire, or other governmental services, providing assistance expressly requested by police, fire, or governmental personnel, or participating in, going to, or returning from a place of work or occupation. No person shall occupy this outside area during the curfew hours except upon authorization of the City of Homestead Police Department. This shall not prohibit a person from, simply, walking a dog in the vicinity of the residence at which the dog is maintained.

Section 4. Effective Date.

This Order and supplement to Declaration shall be effective as of 3 p.m., March 27, 2020, and may be further supplemented from time to time in accordance with Article I, Section 11-5 of Chapter 11 of the City Code. This document shall be posted and distributed as provided by City Code Section 11-5(f).
