## CITY OF DANIA BEACH FOURTH AMENDMENT TO THE SUPPLEMENTAL DECLARATION OF STATE OF EMERGENCY (COVID-19 STATE OF EMERGENCY – April 16, 2020) EXTENSION ORDER

WHEREAS, on March 12, 2020 a State of Emergency was declared in the City of Dania Beach by Mayor Lori Lewellen relating to the Novel Coronavirus Disease 2019 ("COVID-19"), and subsequently supplemented on March 17, 2020, March 18, 2020, March 21, 2020, March 22, 2020, March 27, 2020, and April 10, 2020; and

WHEREAS, as of today, the City of Dania Beach is aware of confirmed cases of COVID-19 within its jurisdictional boundaries. To limit the potential community spread of COVID-19, it is now necessary for the City of Dania Beach to extend restrictions for the general health, safety, and welfare of the community; and

WHEREAS, pursuant to Section 252.38(3) and 252.46, Florida Statutes, Florida Governor DeSantis's Executive Order 20-52, Section (4)(0)(1) (dated March 9, 2020), which provides that a municipality in the State of Florida is authorized to waive the procedures and formalities otherwise required of the political subdivisions by law pertaining to the taking of whatever prudent action is necessary to ensure the public's health, safety, and welfare, and Article 2, Section 1 of the Charter of the City of Dania Beach, the Mayor has the power to issue emergency orders with the force of law. The Mayor has expressly been authorized to issue Emergency Orders; and

WHEREAS, COVID-19 is a respiratory illness caused by a virus that spreads rapidly from person to person and may result in serious illness or death, and constitutes a clear and present threat to the lives, health, welfare, and safety of the people of the City of Dania Beach, Florida.
