SUPPLEMENT TO CITY OF DANIA BEACH DECLARATION OF STATE OF EMERGENCY (COVID-19 STATE OF EMERGENCY –MARCH 18, 2020)

WHEREAS, due to the Coronavirus Disease 2019 (COVID-19), which disease has spread throughout the world, and Florida, and as residents are at risk due to the virus's spread, there is a clear and present threat to the health, safety, and welfare of the citizens and visitors of the City of Dania Beach; and

WHEREAS, pursuant to the Mayor's Emergency Powers, and pursuant to the proclamations and declarations of Emergency issued by the President of the United States, the Governor of the State of Florida and the Mayor of Dania Beach; and

WHEREAS, all parts of this Supplemental Emergency Declaration shall be in force at 5:00 p.m. on the date of execution of this order appearing above for 30 consecutive days:

BY ORDER OF THE MAYOR under her emergency powers authority:

- 1. The City Manager shall advise all restaurants which have existing drive-thru facilities (and which have existing business tax receipts issued by the City) that they may continue their normal take-out/drive-thru operations and may operate twenty-four (24) hours per day in that capacity.
- 2. All restaurants, breweries, and any other food service business establishment within the City shall close on-premises service of customers; however, such establishments may operate their kitchens for the purpose of providing delivery services, take out or exterior pick-up. Patrons are to be advised not to stand in line within ten (10) feet of each other or to wait in their cars until they receive a message from the restaurant that their order is ready. Restaurants should remind and periodically advise their patrons to stay 10 feet apart, or alternatively, to remain in their cars. All restaurants, breweries, and other food service establishments are mandated to cease all on-premises service. However, such establishments may continue to operate their kitchens for drive-thru, delivery, take-out, and exterior pick-up food services.
- 3. All meetings of the City Commission, City Boards, Code Compliance/Special Master Hearings are postponed indefinitely.
- 4. All City sponsored events (other than related to this crisis) are postponed indefinitely.
- 5. All recreational programs and facilities, facility rentals and organized sports and leagues are postponed indefinitely.
- 6. The public beach in the City of Dania Beach, including any access roads to or from the beach are closed.
- 7. All public gatherings of any type, whether organized or otherwise, of greater than 10 persons are prohibited. Grocery stores, gas stations, convenience stores, banks, credit unions, financial institutions, hardware stores, auto-supply stores, hospital, urgent care

- facilities, healthcare and medical facilities, pharmacies, drug stores, medical supply companies, land or facilities owned and managed by Broward County, the Broward County School Board, the City, a hospital, the state of Florida and the Federal Government are exempt from this regulation.
- 8. All bars, nightclubs, taverns, pubs, cocktail lounges, breweries, dance halls, movie theaters, halls for hire, auditoriums, bowling alleys, video arcades, and other like entertainment facilities and businesses, including but not limited to those contained within a hotel or other enclosed facility or structure, shall close.
- 9. All gyms, fitness centers, fitness studios, dance studios, karate facilities, and gymnasiums shall close. This regulation shall not apply to gymnasiums, fitness centers and fitness studios which (a) are amenities of hotels or office buildings and which have a capacity of 10 persons or less; or (b) are an amenity of residential buildings.
- 10. All City Parks, including recreational facilities are closed.
- 11. Businesses exempted above shall have alcohol-based hand sanitizer at every entrance for use by persons upon entering and exiting.
- 12. All citizens and visitors of the City of Dania Beach are directed to comply with these emergency regulations and necessary measures, which shall be strictly enforced, and to cooperate with public officials and public safety personnel in executing any emergency operational plans, and to obey and comply with the lawful direction of all properly identified public officers.
- 13. Any violation of any rule or regulation issued shall be enforceable and punishable as provided in Chapter 13, of the Code of Ordinance of Dania Beach.
- 14. City Hall is closed, however, all essential services such as the Broward Sheriff's Office, Fire Department, Sanitation, and City Utilities continue to operate on a normal basis.
- 15. The City of Dania Beach's prior Declarations of Emergency regarding COVID-19 from March 12, 2020 remains in force, provided however, that if there is any conflict between this Supplement and that Declaration, this Supplement shall prevail. This Supplemental Declaration of Emergency supersedes and suspends all prior declarations regarding restaurant operations.

IT IS BE FURTHER ORDERED BY THE MAYOR under her emergency powers authority:

- 16. That the Mayor may make and issue rules and regulations on matters reasonably related to the protection of life and property as affected by the current emergency; provided, however, the rules and regulations must be confirmed at the earliest practicable time by the City Commission.
- 17. That the Mayor obtain vital supplies, equipment, and such other properties found lacking and needed for the protection of life and property and bind the City for the fair value thereof, and, if required immediately commandeer the same for public use.
- 18. That the Mayor require emergency services of any City officer or employee and due to the state of emergency, command the aid of as many citizens of this community as she

- deems necessary in the execution of her duties; such persons shall be entitled to all privileges, benefits, and immunities as are provided by state law for registered disaster service workers.
- 19. That the Mayor requisition necessary personnel or material of any City Department or agency.
- 20. That the Mayor execute all of her ordinary powers, all of the special powers conferred upon her by the Charter and the City Code of the City of Dania Beach, and by resolution or emergency plan adopted by the City Commission, all powers conferred upon her by any statute, agreement approved by the City Commission, and by any other lawful authority.
- 21. This authority as to all parts of this order shall be effective upon execution, and enforceable at 5:00 p.m., this Wednesday, March 18, 2020, for a period of 30 days, up and through and including April 17, 2020.
