

CITY OF DORAL EMERGENCY ORDER No. 2020-36

Emergency order imposing additional requirements on all essential commercial and retail establishments.

WHEREAS, section 252.38(3)(a), Florida Statutes, gives political subdivisions the authority to declare and enact a State of Local Emergency for a period of up to seven days, thereby waiving the procedures and formalities otherwise required of the political subdivision by law; and

WHEREAS, on March 26, 2020 the City of Doral issued "Safer at Home" Emergency Order 2020-01 which was extended by Emergency Order 2020-02 on April 2, 2020.

WHEREAS, under the of Section 1.04 of the City Charter, the Mayor and City Council have the broadest exercise of home rule powers permitted under the Constitution and laws of the State.

WHEREAS, the City Charter grants to the Mayor in a State of Emergency the authority to take actions as may be necessary to protect the lives and health of the residents of the citizens of Doral.

WHEREAS, COVID-19/novel Coronavirus poses a health risk to City of Doral residents, particularly elderly residents and those who are immunosuppressed or otherwise have high-risk medical conditions; and

WHEREAS, COVID-19 cases in both the State of Florida and Miami- Dade County are trending upwards after a period of containment; and

WHEREAS, holiday gatherings, such as those that occurred in many places over Memorial Day, may have driven the spread of COVID-19

WHEREAS, individuals and families often gather in large numbers on Miami Dade County beaches and at pools within the City of Doral over the Fourth of July weekend, including many tourists and individuals from other places in Florida and elsewhere; and

WHEREAS, crowed beaches, pools, parades, and fireworks displays over the Fourth of July weekend could threaten to accelerate the spread of COVID-19 in the City of Doral.



THEREFORE, as Mayor of the City of Doral I hereby order effective at 11:59 pm on July 3rd, 2020:

Section 1. In order to ensure compliance with the CDC social distancing requirements, all hotels, motels and commercials lodging establishments are to:

- a) Close pools between the hours of 8 p.m. each night and 6 a.m. the next morning;
- b) Limit the use of pools to guests staying in rooms at the establishment, and limit overall capacity to
 50 percent of the pool deck capacity;
- c) Not permit alcohol consumption or sales on pool decks prior to 11:00 a.m.;
- d) Only permit guests staying at the establishment to access rooms, and to strictly observe room occupancy limits;

Hotels, Motels, and commercial lodging establishments which violate those requirements shall be required to close their pool and pool deck until 12:01 a.m., July 7th,2020.

Section 2. Commencing on July 1st, 2020 at 11:59 p.m., restaurants and other food services establishments with seating for more than eight people shall close for on-premises dining between 12:01 a.m. and 6:00a.m. each day. Notwithstanding the foregoing, such establishments may operate their kitchens for the purpose of providing delivery services, pick up or take out services. Employees, janitorial personnel, contractors, and delivery personnel shall be allowed access to such establishments at all times.

Section 3. the following establishments shall remain closed:

- a) Bars, pubs, night clubs, cocktail lounges, cabarets, hookah lounges and breweries provided, however, that such venues, if licensed as a public food service establishment pursuant to chapter 509, Florida Statues, may:
 - Sell food and alcoholic beverages for onsite consumption in conformance with the rules for restaurants set forth in the Handbook, and



- 2. Have performances if performers are no less than ten feet from patrons at all times and such patrons observe such performances from tables or stationary seats.
- b) Movie theaters, concert houses, auditoriums, playhouses, bowling alleys, arcades, indoor amusement facilities, and casinos, provided, however, that such venues may operate if they
 - Have submitted to, and received approval from the County a reopening and operation plan for COVID-19 mitigation in accordance with the standards set forth in the Handbook; and
 - 2. Operate in conformance with the approved plan.
- c) Concerts, conventions, and other temporary events, except outdoor events which may be held with appropriate social distancing, such as attendees remaining in their own cars.

Section 4. This order is supplemental to the requirements of all prior applicable executive orders.

The Emergency measures that have been ordered and promulgated above effective are through July 8th, 2020.
