

CITY OF DORAL EMERGENCY ORDER No. 2020-48

WHEREAS, on March 25th, 2020 the City of Doral declared a local State of Emergency; and

WHEREAS, on May 14, 2020 Governor DeSantis issued Executive Order 20-122. initiating Phase 1 of the Safe. Smart. Step-by-Step. Plan for Florida's Recovery to Miami Dade County; and

WHEREAS, the City recognizes the impact of economic hardship, but the risk of COVID-19 infection is still real for all Floridians. Therefore, each business should review the guidance that is relevant to their workplace, prepare a plan based on the guidance for their industry, and put it into action; and

WHEREAS, the City Charter grants to the Mayor in a State of Emergency the authority to take actions as may be necessary to protect the lives and health of the citizens of Doral.

THEREFORE, under the of Section 1.04 of the City Charter, and the home rule powers permitted under the Constitution and laws of the State, the City of Doral will open and implement the County's reopening plan.

Section 1. Re-opening of Establishments.

A. Every retail and commercial establishment and any other establishment or facility (collectively, "establishment") in the City of Doral is permitted to open, and remain open, provided that each such establishment complies with the following requirements at all times:




- 1. Requirements established in Miami Dade Emergency Order 28-20.
- 2. Facial covering requirements in Miami Dade Emergency Order 20-20, as amended.
- 3. The entry of County or municipal personnel onto the establishment's property for the sole purpose of inspection for compliance with this order.

Section 2. Noncompliance of Regulations. In the event that an establishment is not in compliance with the specific requirements in the Moving to New Normal Handbook, ("Handbook"), the establishment shall immediately be required to close for a minimum of 24 hours until the conditions for reopening outlined in Section 1.b. the of Miami Dade Emergency Order 28-20 have been met.

Section 3. Food Service Establishments. Restaurants and other food services establishments with seating for more than eight people must be limited to no more than 50% of its building occupancy with the maintenance of social distancing of 6 feet between parties.

- Any outdoor seating must maintain similar distancing but in no event may the combined indoor and outdoor operation exceed <u>100% of its legally permitted</u> <u>building occupancy</u>.
- 2. All bar counters must remain closed to seating.
- 3. Restaurants and other food services establishments shall close for onpremises dining between the start of the curfew as determined in Emergency Order 27-20 and 6:00 a.m.



- 4. Notwithstanding the foregoing, such establishments may operate their kitchens for the purpose of providing delivery services, pick- up or take out services. Employees, janitorial personnel, contractors and delivery personnel shall be allowed access to such establishments at all times.
- B. As a condition of opening all establishments must:
- Post CDC signage in public locations emphasizing measures to "Stop the Spread" and to exercise social responsibility;
 - 2. Train all personnel in new operating protocols and modifications to existing codes of conduct to deal with COVID-19 issues;
 - 3. Reduce seating in breakrooms and common areas to ensure a minimum physical distance of six feet between people, and where possible, establish a single point of entrance;
 - 4. Post a contact email address, telephone number or both for employees and customers to raise questions or concerns;
 - 5. If faced with infection from on-site personnel, immediately report the number of infected persons, time of infection, and proposed remediation plan to the Florida Department of Health, as further specified in the handbook;
 - 6. Enhance sanitization of all common areas and frequent touch points;



- 7. Place trash containers for facial coverings and other personal protective equipment near exits, entrances, and other common areas;
- 8. Comprehensively clean establishments each night, including thoroughly disinfecting all frequent touch points and emptying all trash receptacles using solid waste bags that are double-bagged and securely sealed;
 - 9. Install hand sanitizer at entry points and throughout the property;
- 10. Use reasonable efforts to ensure that on-site customers, employees, contractors, and vendors maintain appropriate social distancing, as recommended by the then-current CDC guidelines, which may include, but are not limited to, marking floors at appropriate intervals or providing other visible systems to identify the appropriate social distance; and
- 11. Comply with any restrictions or requirements imposed pursuant to any Executive Order issued by the Governor, including, but not limited to, building capacity restrictions.

Section 4. Establishments that must remain closed.

1. Bars, pubs, night clubs, ballrooms both stand alone and incident to any hotel, banquet halls, cocktail lounges, cabarets, hookah lounges, and breweries, provided, however, that such venues, if licensed as a public food service establishment pursuant to chapter 509, Florida Statues, may only sell food and alcoholic beverages for onsite consumption in conformance with the rules for restaurants set forth in the Handbook.



- Movie theaters, concert houses, convention spaces, auditoriums, playhouses, bowling alleys, arcades, indoor amusement facilities, and adult entertainment;
- Concerts, conventions, and other temporary events, except outdoor events
 which may be held with appropriate social distancing, such as attendees
 remaining in their own cars.

Section 5. Adoption and incorporation of Miami Dade County Emergency
Order 28-20.

The City adopts and incorporates Miami Dade County Emergency Order 28-20.

Section 6. Failure to comply.

Failure to comply with this Order shall constitute a misdemeanor subject to fines and imprisonment punishable as provided in F.S. §§ 775.082 and 775.083.

The Emergency measures that have been ordered and promulgated above effective are extended through September 7th, 2020.
