ORDER NUMBERING ALL EMERGENCY ORDERS ISSUED BY THE CITY OF HIALEAH IN RESPONSE TO COVID-19 FOR EASE OF REFERENCE (COVID-19-COH-EO-16)

ATTEST

WHEREAS, on March 9, 2020, Governor Ron DeSantis issued Executive Order Number 20-52 declaring a state of emergency for the State of Florida as a result of the threat of the spread of Coronavirus Disease 2019 (COVID-19); and

WHEREAS, On May 9, 2020, Governor Ron DeSantis issued Executive Order 20-114 extending the State declaration of emergency for an additional 60 days;

WHEREAS, on March 12, 2020, County Mayor Carlos Gimenez also declared a countywide state of emergency in response to the first reported case of coronavirus infection in Miami-Dade County and the County has continued to declare that we remain in a state of emergency extending the declaration weekly as required by law; and

WHEREAS, On behalf of the City, I declared a state of emergency on Monday, March 16, 2020 at 10:23 a.m. and that declaration remains in effect to date; and

WHEREAS, during this emergency I have issued the orders on the dates and times set forth in the table provided below; and

WHEREAS, the State and County are, as is the entire country, are presently grappling with the decision to reopen society and restart economic activity by lifting stay at home orders and closure orders; and

WHEREAS, as we consider phased reopening and restarting our economy and societal interactions, we will need stricter enforcement of emergency safety measures for the common good of all members in our community; and

WHEREAS, Chapter 252, Florida Statutes, gives authority to political subdivisions to declare a state of local emergency for a limited duration, thereby waiving the procedures and formalities otherwise required of the political subdivision by law; and

WHEREAS, Coranavirus Disease 2019 (COVID-19) requires extraordinary and immediate actions by the City of Hialeah in order to maintain order and protect the life, health, safety and welfare of the public.

THEREFORE, to facilitate the public's understanding and our law enforcement officers' reference to each City emergency order issued and any future emergency order and to distinguish emergency orders from those issued by the County or the State

EFFECTIVE IMMEDIATELY, I HEREBY ORDER:

1. All Emergency Orders issued to date by the City of Hialeah in response to the COVID-19 pandemic are hereby numbered sequentially in the order issued and in the manner provided in the following table:

2. Any future emergency orders issued shall be sequentially numbered using the same alphanumeric designation of COVID-19 (describing the emergency event), COH (City of Hialeah), EO (Emergency Order) and the next number in the sequence. If a prior order is amended then the alphanumeric reference shall end with a letter in the order of the alphabet corresponding to the amendment number for the specific order referred to by the number issued immediately preceding the number of the order being amended. For example, the First Amendment to the City's Curfew Order is numbered COVID-19-COH-EO-4 (number of original Curfew Order)-A (indicating it is the first amendment).
