



**LOCAL DECLARATION OF EMERGENCY
CITY OF LIGHTHOUSE POINT, FLORIDA
MAYOR GLENN TROAST**

ORDER 20-04

WHEREAS, Novel Coronavirus Disease 2019 (COVID-19) is a severe acute respiratory illness that can spread among humans through respiratory transmission and presents with symptoms similar to those of influenza; and

WHEREAS, on March 2, 2020, Governor DeSantis issued Executive Order 20-51, directing the Florida Department of Health to issue a Public Health Emergency; and

WHEREAS, on March 9, 2020, Governor DeSantis issued Executive Order 20-52, declaring a state of emergency for the State of Florida for sixty days unless extended; and

WHEREAS, on March 16, 2020, the White House issued guidelines recommending the avoidance of gatherings of 10 people or more; and

WHEREAS, on April 1, 2020, Governor DeSantis issued Executive Orders 20-91 and 20-92, which, among other things, ordered residents of the State of Florida to be Safer at Home and redefined Essential Services to include the list maintained by the US Department of Homeland Security in its Guidance on the Essential Critical Infrastructure Workforce, v. 2 and any subsequent lists published by the State Coordinating Officer and, to extent incorporated into the Governor's Executive Orders, Miami-Dade County Emergency Order 07-20 as amended; and,

WHEREAS, the State of Emergency declared in Executive Order 20-52 remains in full force and effect, as well as the limitation on availability of services to "essential services" in Executive Orders 20-91 and 20-92, and the White House/CDC guidelines for limiting gatherings of people and for social distancing.

NOW THEREFORE, I, GLENN TROAST, THE MAYOR OF THE CITY OF LIGHTHOUSE POINT, FLORIDA, HEREBY PROCLAIM AND DECLARE:

SECTION 1. This Order is issued pursuant to the authority of State Emergency Management Act, Sections 252.18-252.60, Florida Statutes, and Section 2-34 of the City of Lighthouse Point Code of Ordinances. It supplements the March 20, 2020, Local Declaration of Emergency (Amended), Lighthouse Point Emergency Order 20-02 issued on March 26, 2020, and Lighthouse Point Amended and Restated Safer at Home Order 20-03 issued on April 2, 2020, all of which remain in full force and effect except to the extent modified by this Emergency Order 20-04.

SECTION 2. All May meetings of City Boards and Advisory Committees, and the Code Enforcement Special Magistrate, are cancelled.


SECTION 3. Effective Date. This Emergency Order is effective as of April 24, 2020.
