LOCAL DECLARATION OF EMERGENCY CITY OF LIGHTHOUSE POINT, FLORIDA MAYOR GLENN TROAST

ORDER 20-07

WHEREAS, on May 15, 2020, City of Lighthouse Point Order 20-06 was issued to implement Phase 1 Re-Opening in the City of Lighthouse Point; and,

WHEREAS, the City has consulted with officials in Pompano Beach, and it has been agreed that Exchange Club Park should re-open; and,

WHEREAS, the use of beaches at DeGroff and Exchange Club Parks should be governed by orders of Broward County; and,

WHEREAS, the City Library has opened for pick up online services.

NOW THEREFORE, I, GLENN TROAST, THE MAYOR OF THE CITY OF LIGHTHOUSE POINT, FLORIDA, HEREBY PROCLAIM AND DECLARE:

SECTION 1. This Order is issued pursuant to the authority of State Emergency Management Act, Sections 252.18-252.60, Florida Statutes, and Section 2-34 of the City of Lighthouse Point Code of Ordinances. This Order is supplemental to Lighthouse Point Order 20-06, which remains in full force and effect except as amended herein or as may be inconsistent with this Order.

SECTION 2. Exchange Club Park. Section 6(C) of Order 20-06 is amended to provide for the re-opening of Exchange Club Park, to read as follows:

Exchange Club Park shall re-open on Monday, June 1, 2020. The hours the park is open will be determined by the City Administrator or Mayor.

SECTION 3. City Library. Section 5 of Order 20-06 is amended to provide for the re-opening of the City's Library as follows:

The Library is open for pick up online. Further opening will be at the discretion of the Library Director.

SECTION 4. <u>Use of Beaches at DeGroff and Exchange Club Parks.</u> The use of the beaches at DeGroff and Exchange Club Parks, including the beaching, landing and anchoring of boats and watercraft, shall be the same as restricted or permitted by Broward County as set forth in Broward County Emergency Orders, as amended from time.

SECTION 5. Enforcement. This Order may be enforced by any law enforcement officer of the City of Lighthouse Point, or any officer or employee with any agency with jurisdiction over matters covered by this Order.

SECTION 6. Filing with City Clerk. This Order shall be filed promptly with the City Clerk and shall be given prompt and general publicity.

SECTION 7. Conflict. In the event of a conflict between this Order and previous City of Lighthouse Point Emergency Orders, the provisions of this Order shall prevail.

SECTION 8. <u>Duration</u>. This Order shall take effect upon signature of the Mayor at the time and on the date below, and shall be in effect for as long as the State of Florida State of Emergency is in effect, unless modified or earlier terminated.

SECTION 9. Effective Date. This Emergency Order is effective immediately.
