



ORDER No. 20-09

**LOCAL EMERGENCY MEASURES IMPLEMENTED BY THE
CITY MANAGER OF THE CITY OF MIAMI, FLORIDA**

WHEREAS, under the provisions of law and Sections 252.31 - 252.60, Florida Statutes, Mayor Francis X. Suarez of the City of Miami declared on March 12, 2020 that a State of Local Emergency exists within the City of Miami, Miami-Dade County, Florida in response to the Novel Coronavirus ("COVID-19"); and

WHEREAS, on March 17, 2020, March 24, 2020, March 31, 2020, April 7, 2020, April 14, 2020, April 21, 2020, April 28, 2020, May 5, 2020, and May 12, 2020, in accordance with the provisions of Section 252.38(3)(a), Florida Statutes, City of Miami Mayor Francis X. Suarez declared extensions to the State of Local Emergency in response to COVID-19 in and for the City of Miami, Florida; and

WHEREAS, the effects of COVID-19 continue to require extraordinary and immediate actions by the City of Miami in order to protect the public's health, safety, and welfare; and

WHEREAS, Executive Order 20-52, Section (4)(D)(1), and the extension of Executive Order 20-52 pursuant to Executive Order 20-114, provides that each municipality in the State of Florida is authorized to waive the procedures and formalities otherwise required of the political subdivision by law pertaining to the taking of whatever prudent action is necessary to ensure the public's health, safety, and welfare; and

WHEREAS, COVID-19 is a natural emergency whose effects are still being felt within the City of Miami and that on account thereof, there is reason to believe that it is

necessary to take whatever prudent action is necessary to ensure the health, safety, and welfare of the City of Miami; and

WHEREAS, the City of Miami believes, based on the currently available data relating the number of new cases of COVID-19 and associated hospitalizations, this is the appropriate time to begin reopening limited facilities with safety measures intended to protect its residents; and

WHEREAS, it is important for the physical and mental health of the community that outdoor recreation be allowed to the extent it is safe to do so; and

WHEREAS, the City of Miami has determined that it is possible to open, with restrictions intended to prevent the spread of COVID-19, its marinas and associated marina facilities and services; and

WHEREAS, despite the opening of the sites listed herein, it is necessary and appropriate to take action to ensure that COVID-19 does not continue to spread and that the residents and employees of the City remain safe and secure;

NOW, THEREFORE, I, Arthur Noriega V, City Manager of the City of Miami, County of Miami-Dade, State of Florida, acting under the authority granted to municipalities by Florida Statutes Sections 252.38, et seq., 501.160, and Executive Order Number 20-52 promulgated by Governor Ron DeSantis on March 9, 2020, and Executive Order 20-114, executed on May 8, 2020, extending Executive Order 20-52 an additional 60 days, as well as the authority granted to me by Section 4(g)(3) of the Charter of the City of Miami, Florida, as amended and by Chapter 8A-5 of the Miami Dade County Code, and in addition to the Local Emergency Measures I have previously ordered, hereby **ORDER** and promulgate the following additional Local Emergency Measures for the City of Miami **effective May 14, 2020, at 7:00a.m.:**

- I. The following City of Miami marinas and their associated marina facilities will be open to the public subject to the restrictions listed at each location:

A. Dinner Key Marina:

1. Hours of Operation – The Dinner Key Marina shall be open to the public seven (7) days a week between the hours of 7:00 a.m. and 5:00 p.m.
2. Dock Master Building - Everyone in and around the Dinner Key Marina dock master building shall be required to wear a facial covering which shall mean a covering of the nose and mouth and shall include a face mask, homemade mask, or other cloth covering such as a scarf, bandana, handkerchief, or other similar cloth covering at all times.
 - a. Only a maximum of two (2) persons shall be allowed inside the office, not including marina staff.
 - b. At all times, each person in and around the dock master building shall practice social distancing and maintain a minimum of six (6) feet apart.
 - c. Restrooms located in the dock master building shall be available for marina customers only.
 - d. The customer lounge located on the second floor of the dock master building shall remain closed until further notice.
 - e. All seating in and around the premises of the dock master building shall not be used by anyone.
3. Services- The following services at the Dinner Key Marina will be available:
 - a. Waste pumpout services will be conducted each Wednesday for Mooring Field customers only and each Thursday for the customers that are inside the marina basin only. Any customers under this criterion must notify Dinner Key Marina staff in advance via electronic mail if they would like to be added to the pumpout list.
 - b. Customers expecting to receive mail and packages can retrieve their items between the hours of 8:00 a.m. and 12:00 p.m. (noon) daily.

- c. The laundry room located in the dock master building will be open to Dinner Key Marina customers only. While using the laundry room, customers shall practice social distancing and maintain a minimum of six (6) feet apart.
 - d. Shuttle boat services will remain out of service until further notice.
 - e. Dinner Key Marina and Mooring Field will be accepting new customers.
4. Parking- The Dinner Key Marina parking lot will be available for marina customers only. Temporary parking passes will not be issued. Guests will be directed to park their vehicles in Lot 62 (Pay-by-Phone).

B. Miamarina

- 1. Hours of Operation – The Mimarina shall be open to the public seven (7) days a week between the hours of 7:00 a.m. and 5:00 p.m.
- 2. Dock Master Building - Everyone in and around the dock master building is required to wear a facial covering which shall mean a covering of the nose and mouth and shall include a face mask, homemade mask, or other cloth covering such as a scarf, bandana, handkerchief, or other similar cloth covering at all times.
 - a. Only a maximum of one (1) person shall be allowed inside the dock master building office, not including marina staff.
 - b. At all times, each person in and around the dock master building shall practice social distancing and maintain a minimum of six (6) feet apart.
 - c. Restrooms located in the dock master building shall be available for marina customers only.
 - d. The laundry room located in the dock master building will be open to Miamarina customers only. While using the laundry room, customers shall exercise social distancing rules and maintain a minimum of six (6) feet apart.
- 3. Services - Miamarina will be accepting new customers.

C. Marine Stadium Marina:

1. Hours of Operation – The Marine Stadium Marina shall be open to the public seven (7) days a week between the hours of 7:00 a.m. and 5:00 p.m.
2. Dock Master Building - Everyone in and around the dock master building is required to wear a facial covering which shall mean a covering of the nose and mouth and shall include a face mask, homemade mask, or other cloth covering such as a scarf, bandana, handkerchief, or other similar cloth covering at all times.
 - a. Only a maximum of one (1) person shall be allowed inside the office, not including marina staff.
 - b. Restrooms located in the dock master building shall be available for marina customers only.
3. Services - The following services at the Marine Stadium Marina will be available:
 - a. Owners of vessels stored at the marina may request that their vessel be placed in the water for use however, the owner of the vessel must be present at the marina at the time of the request. Marina staff are prohibited from accepting such requests via electronic mail or by phone.
 - b. Any vessel placed in the water must depart the marina immediately.
 - c. Fuel stations are available to the public however all occupants must remain on the vessel throughout the duration of the fueling. A marina staff member will be on site to assist with fueling a vessel and processing payment. The vessel must depart the marina immediately upon completion of the transaction.
 - d. At all times, each person in and around the dock master building and/or the marina fueling station shall practice social distancing and maintain a minimum of six (6) feet apart.

II. All public and private marinas may open to the public and shall be subject to the general restrictions listed herein:

A. Boat Capacity (Non-Commercial):

1. Limitations on the use of boats on-water will be enforced pursuant to Florida statutes and by any law enforcement that has subject matter jurisdiction.
2. Notwithstanding the above, boats less than 25 feet can have a maximum of eight (8) people on board. Up to four (4) of the people can be adults. The others must be children who are 17 and under; and
3. Boats between 25 and 36 feet can have a maximum of ten (10) people on board. Up to six (6) of the people can be adults. The others must be children who are 17 and under; and
4. Boats greater than 36 feet can have a maximum of ten (10) people on board. Up to eight (8) of the people can be adults. The others must be children who are 17 and under.

B. Charters and Jet Ski Rentals (Commercial):

1. Captains, crewmembers, and patrons on a charter vessel shall wear facial coverings, gloves and practice social distancing at all times.
2. The operation of "Six-Pack" vessels shall be restricted to no more than four (4) occupants per vessel.
3. Charter vessels shall adhere to CDC guidelines providing for social distancing which shall include delineating "safe" social distancing positions for patrons on seats, vessel railings and deck utilizing tape or other markings.
4. All persons fishing shall have their own fishing poles and tackle. Rental of fishing poles and related equipment is prohibited.
5. CDC cleanliness guidelines shall be posted in the charter vessel's restrooms/heads. The restroom onboard shall be sanitized and disinfected hourly and after each trip or as needed. Soap, water, and/or hand sanitizer shall be provided for all patrons.

6. Fish cleaning/bait table stations: Only one (1) person per fish cleaning/bait table station shall be allowed at a time. Fish cleaning and bait table stations shall be cleaned with soap and water or a disinfecting agent between each charter.
7. If crew members are filleting fish a patron caught, only one (1) person shall be allowed per table.
8. All persons shall practice social distancing and utilize facial coverings at landside operations of charter vessel including check-in locations.
9. Charter operators shall delineate safe social distance positions for those waiting in line to check in or out with tape or other markings.
10. Staff and patrons must wear facial coverings, while on the dock, practicing safe social distancing.
11. Jet ski rental operators shall limit rentals of jet skis to single riders only. The rental operator shall sanitize and disinfect each jet ski upon return of the rental with CDC approved products.

C. City of Miami Boat Ramps:

1. All City of Miami public boat ramps and boat launches shall remain closed to the public until further notice.

D. Operation of Boats:

1. The operation of boats on-water shall be consistent to the restrictions as listed in Miami-Dade County Emergency Order 21-20, Section 5, subsection titled "ON-WATER ACTIVITIES", as amended by Miami-Dade County, and incorporated herein by reference, or subsequent amended Local Emergency Measures by the City of Miami.

The above Local Emergency Measures shall take effect on **May 14, 2020 at 7:00 a.m.** All requirements of this Local Emergency Measure and all Miami-Dade County Emergency Orders and State of Florida Executive Orders not in conflict with this Order shall be strictly adhered to at all times and enforceable pursuant to Florida Statutes and the Code of the City of Miami.
