

RESOLUTION NO. 2020-017

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA, EXTENDING THE STATE OF LOCAL EMERGENCY RELATING TO THE COVID-19 PANDEMIC UNTIL MAY 20, 2020; PROVIDING FOR EXECUTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on March 13, 2020, in accordance with City of Parkland Code Section 2-101(c) and Chapter 252, Florida Statutes, the Mayor declared a State of Emergency within the City of Parkland, Florida to begin on March 13, 2020 and ending on March 20, 2020 (the DECLARATION) ; and

WHEREAS, on March 18, 2020, by virtue of Resolution 2020-015 the City Commission extended the DECLARATION for a period of thirty (30) days until April 20; and

WHEREAS, on April 20, 2020, the City Commission adopted Emergency Ordinance No. 2020-010 which amended Section 2-101(c) of the City Code to enable the City Commission to further extend the State of Emergency for additional thirty-day periods; and

WHEREAS, the City incorporates the following findings in support of its extension of the State of Emergency:

- (A) The findings of Executive Orders Number 20-51 and 20-52 of Governor DeSantis (and subsequent Orders 20-53 through 20-59);
- (B) The findings of the Emergency Declaration Order of Bertha Henry dated March 10, 2020 (and subsequent Emergency Orders);
- (C) The findings of the President of the United States in his Declaration of National Emergency.

WHEREAS, the City Commission believes that the health concerns related to the COVID-19 virus as set forth in the above referenced declarations of emergency will remain after the termination of the DECLARATION on April 20, 2020 and require extension of the State of Emergency in the City of Parkland for and additional thirty (30) days; and

WHEREAS, the City Commission adopts the findings incorporated in the DECLARATION and further finds that the emergency conditions found therein and the Recitals as set forth above continue to exist and that it is necessary and in the best interest of the health, safety and welfare of the citizens of Parkland to

extend the DECLARATION for and additional thirty (30) days; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA, AS FOLLOWS:

Section 1. The above referenced “Whereas” clauses are true and correct and made a part hereof.

Section 2. The City Commission hereby extends the State of Emergency in the City of Parkland set forth in the DECLARATION for an additional 30 days beyond its expiration date of April 20, 2020. The Mayor and the City Manager are hereby authorized to do all things necessary to carry out the extension and exercise all powers provided for in Section 2-101(c) of the City Code and as authorized in the Governor’s Executive Order Numbers 20-51 through 20-91 and the Emergency Declarations of County Administrator, Bertha Henry, and Florida Statutes Chapter 252, and as otherwise necessary in the interests of protecting the health, safety and welfare of the public and all city employees during the emergency. This Resolution also incorporates all future Executive Orders of the Governor relating to the COVID-19 Public Health Emergency. The City Manager and Mayor shall have all powers and authority to carry out and enforce such orders and take such actions necessary to protect the public health, safety and welfare. All orders of the City Manager issued in response to the emergency are hereby ratified and confirmed and shall continue in full force and effect until terminated by the City Manager, or City Commission or the termination of the emergency period, whichever event occurs first.

Section 3. That the Mayor is hereby authorized to execute this Resolution.


Section 4. This Resolution shall become effective immediately upon adoption.
