

**CITY OF WESTON, FLORIDA
EMERGENCY ORDER NO. 2020-18**

WHEREAS, First, Novel Coronavirus Disease 2019 (“COVID-19”) is a severe acute respiratory illness that can spread among humans through respiratory transmission and presents with symptoms similar to those of influenza; and

WHEREAS, Second, on March 2, 2020, Governor DeSantis issued Executive Order 20-51, directing the Florida Department of Health to issue a Public Health Emergency; and

WHEREAS, Third, on March 9, 2020, the Governor issued Executive Order 20-52, providing political subdivisions within the State with the authority to waive procedures and formalities otherwise required by law pertaining to:

- performing of public work and taking whatever prudent action is necessary to ensure the health, safety, and welfare of the community;
- entering into contracts;
- incurring obligations;
- employment of permanent and temporary workers;
- utilization of volunteer workers;
- rental of equipment;
- acquisition and distribution, with or without compensation, of supplies, materials and facilities;
- appropriation and expenditure of public funds; and

WHEREAS, Fourth, on March 16, 2020, the City of Weston declared a State of Local Emergency, which has been extended each week thereafter (the “COVID-19 State of Emergency”); and

WHEREAS, Fifth, on March 17, 2020, the Governor issued Executive Order 20-68, setting forth, among other things, certain requirements for bars, pubs, nightclubs and restaurants; on March 20, 2020, the Governor issued Executive Order 20-71, setting forth, among other things, additional and supplemental requirements for alcohol sales and restaurants and bars; and

WHEREAS, Sixth, Section 60.03(A)(6), of the Code of Ordinances, empowers the City Manager to issue orders necessary for the protection of life and property, establishment of public order, and control of adverse conditions affecting public welfare resulting from an Emergency, and to adopt order issues by Federal, State or Broward County Emergency management agencies; and

WHEREAS, Seventh, on March 18, 2020, Donald P. Decker, as City Manager, entered Emergency Order No. 2020-01, requiring that all restaurants close for on premises dining no later than 10:00 PM every night, but could remain open during their normally permitted hours for drive-thru, take-out and delivery services; and

WHEREAS, Eighth, on March 19, 2020, Donald P. Decker, as City Manager, entered Emergency Order No. 2020-02, closing Weston Regional Park, Tequesta Trace Park and Vista Park beginning at 11:00 PM on March 20, 2020, and requiring all restaurants cease all on premises dining beginning at noon on March 20, 2020; provided, however, that restaurants may remain open for their normally permitted hours for drive-thru, take-out and delivery services only; and

WHEREAS, Ninth, on March 22, 2020, Donald P. Decker, as City Manager, entered Emergency Order No. 2020-03, prohibiting all public gatherings of any type, whether organized or otherwise, of greater than 10 persons, with specified exemptions; and

WHEREAS, Tenth, on March 23, 2020, Donald P. Decker, as City Manager, entered Emergency Order No. 2020-04, adopting and incorporating Executive Orders 20-51, 20-52, 20-68, 20-69, 20-70, 20-71 and 20-72 issued by the Governor, and Broward County Emergency Order 20-01; and

WHEREAS, Eleventh, on March 25, 2020, Donald P. Decker, as City Manager, entered Emergency Order No. 2020-05, issuing a Safer at Home Order, and setting forth regulations for Essential Businesses and closing all of the City's parks; and

WHEREAS, Twelfth, on March 30, 2020, Donald P. Decker, as City Manager, entered Emergency Order No. 2020-06, implementing rules of procedure for public meetings utilizing communications media technology; and

WHEREAS, Thirteenth, on March 31, 2020, Donald P. Decker, as City Manager, entered Emergency Order No. 2020-07, closing common use recreational facilities, and adopting and incorporating Executive Order 20-89 issued by the Governor and Miami-Dade County Emergency Order 7-20, including its three amendments; and

WHEREAS, Fourteenth, on April 6, 2020, Donald P. Decker, as City Manager, entered Emergency Order No. 2020-08, encouraging persons to wear cloth facial coverings consistent with CDC guidelines, including cloth masks and adopting and incorporating Executive Orders 20-91 and 20-92 issued by the Governor, and Broward County Emergency Orders 20-03 and 20-05; and

WHEREAS, Fifteenth, on April 10, 2020, Donald P. Decker, as City Manager, entered Emergency Order No. 2020-09, superseding Emergency Order No. 2020-08, and requiring employees and customers of essential businesses as well as delivery service personnel to wear cloth facial coverings while inside the businesses or making deliveries, and adopting and incorporating Broward County Emergency Order 20-06; and

WHEREAS, Sixteenth, on April 29, 2020, Donald P. Decker, as City Manager, entered into Emergency Order No. 2020-10, adopting and incorporating Broward County Emergency Order 20-08 and supplementing such order by setting forth additional requirements; and

WHEREAS, Seventeenth, on May 15, 2020, Donald P. Decker, as City Manager, entered into Emergency Order No. 2020-11, adopting and incorporating Broward County Emergency Order 20-10 and supplementing such order by setting forth additional requirements; and

WHEREAS, Eighteenth, on May 21, 2020, Donald P. Decker, as City Manager, entered into Emergency Order No. 2020-12, adopting and incorporating Broward County Emergency Order 20-12; and

WHEREAS, Nineteenth, on May 24, 2020, Donald P. Decker, as City Manager, entered into Emergency Order No. 2020-13, adopting and incorporating Broward County Emergency Order 20-13; and

WHEREAS, Twentieth, on May 30, 2020, Donald P. Decker, as City Manager, entered into Emergency Order No. 2020-14, adopting and incorporating Broward County Emergency Order 20-14; and

WHEREAS, Twenty-First, on June 6, 2020, Donald P. Decker, as City Manager, entered into Emergency Order No. 2020-15, adopting and incorporating Broward County Emergency Order 20-15 and reopening Weston Regional Park, Tequesta Trace Park and Vista Park; and

WHEREAS, Twenty-Second, on June 10, 2020, Donald P. Decker, as City Manager, entered into Emergency Order No. 2020-16, implementing quasi-judicial procedures for virtual meetings utilizing communications media technology; and

WHEREAS, Twenty-Third, on June 13, 2020, Donald P. Decker, as City Manager, entered into Emergency Order No. 2020-17, adopting and incorporating Broward County Emergency Order 20-17.

NOW, THEREFORE, I, Donald P. Decker as City Manager, hereby declare:

Section 1: Adoption of Broward County Emergency Order 20-18. Broward County Emergency Order 20-18, attached hereto as Exhibit 1, is hereby adopted by the City of Weston and incorporated herein. Additionally, persons entering or walking through indoor common areas of residential condominium and homeowners association buildings are required to wear facial coverings. Common Areas include lobby and reception areas, hallways, elevators, mailrooms, clubhouse and meeting rooms, etc. The respective property managers and building managers shall be required to enforce this requirement.

Section 2: It is the intent of the City to strictly enforce the provisions of this Emergency Order to ensure that all businesses and associations in Weston are operating with proper social distancing and face coverings, consistent with prior County and City Emergency Orders.

Section 3: This Order shall remain in place as long as the COVID-19 State of Emergency is in effect, as amended and extended.

Section 4: The orders and provisions of this Emergency Order and prior applicable State of Florida Executive Orders and Broward County Emergency Orders may be enforced within the boundaries of the City of Weston by the Broward Sheriff's Office, as the City's law enforcement agency, as well as the City's Code Enforcement Officers.

Section 5: Any violation of any rule or regulation issued and set forth herein shall be punishable as provide in Section 2.99 of the Code of Ordinances of the City of Weston.

Section 6: All requirements of this City Emergency Order, Broward County Emergency Orders, and State of Florida Executive Orders shall be strictly adhered to at all times.

Section 7: This Order shall take effect at 12:01 AM on June 26, 2020.

**BROWARD COUNTY ADMINISTRATOR'S
EMERGENCY ORDER 20-18**

WHEREAS, COVID-19, a respiratory illness caused by a virus that spreads rapidly from person to person and may result in serious illness or death, constitutes a clear and present threat to the lives, health, welfare, and safety of the people of Broward County;

WHEREAS, on March 1, 2020, Governor DeSantis declared a Public Health Emergency as a result of COVID-19, and on March 9, 2020, Governor DeSantis issued Executive Order 20-52, declaring a State of Emergency as a result of COVID-19;

WHEREAS, on March 10, 2020, I declared a Local State of Emergency;

WHEREAS, on March 11, 2020, the World Health Organization declared the spread of COVID-19 to be a global pandemic;

WHEREAS, on March 13, 2020, President Trump declared a national emergency concerning COVID-19;

WHEREAS, to reduce the spread of COVID-19, the United States Centers for Disease Control and Prevention ("CDC") recommends implementation of community mitigation strategies to increase containment of the virus;

WHEREAS, on March 10, 2020, the Broward County Board of County Commissioners authorized me to take any appropriate and necessary action to protect the health and safety of Broward County residents and visitors in connection with COVID-19, and other emergency powers including under the state-approved emergency management plan had previously been delegated to me (as further outlined below);

WHEREAS, on April 28, 2020, as part of a coordinated effort with the local municipalities and the adjoining counties, I reopened certain parks, golf courses, and other recreational facilities in Broward County pursuant to the guidelines in Broward County Emergency Order 20-18

County Emergency Order 20-08, as amended by Broward County Emergency Order 20-09;

WHEREAS, beginning on April 29, 2020, Governor DeSantis issued a series of Executive Orders, including Executive Orders 20-112, 20-120, and 20-123, establishing Phase 1 of a step-by-step plan for Florida's recovery (initially excluding Broward, Miami-Dade, and Palm Beach Counties) and permitting certain additional activities for individuals;

WHEREAS, on May 14, 2020, Governor DeSantis issued Executive Order 20-122 permitting Broward and Miami-Dade Counties to participate in the Phase 1 reopening;

WHEREAS, beginning on May 21, 2020, I issued a series of Emergency Orders including Emergency Orders 20-12, 20-13, 20-14, 20-15, and 20-16, which outline the establishments currently permitted to operate in Broward County and incorporate guidelines and requirements for safe operations for opened businesses, amenities, and services;

WHEREAS, in order to increase public awareness of the safety and sanitation measures required to protect public health, on June 12, 2020, I issued Emergency Order 20-17 requiring retail establishments and restaurants to post signage containing information regarding sanitization, social distancing, and facial covering requirements; and

WHEREAS, given an increase in positive reported cases of COVID-19 within our County and the state as a whole, I now find it necessary to impose additional requirements for establishments within the County that fail to comply with the established guidelines;

NOW, THEREFORE, I, Bertha Henry, the Broward County Administrator, pursuant to my emergency authority under Sections 8-53 and 8-56 of the Broward County Code of Ordinances, as well as the authority granted to me by the Declaration of Emergency issued by Governor DeSantis in Executive Order 20-52, by Chapter 252, Florida Statutes, by the Board of County Commissioners, and by the Broward County Comprehensive Emergency Management Plan, hereby order as follows:

Section 1. Closures for Failure to Comply with Applicable Guidelines

Commencing at 12:01 a.m. on Friday June 26, 2020, in addition to being subject to the penalties set forth in Section 8-56 of the County's Code of Ordinances, any establishment (as defined in Emergency Order 20-12) that is cited by the applicable code enforcement or law enforcement authority for operating in a manner inconsistent with or otherwise in violation of any Broward County Emergency Order shall close immediately. Such establishment may reopen only after (1) a minimum of a twenty-four (24) hour period during which the establishment shall conduct a thorough review of the County's applicable Emergency Orders, including Emergency Order 20-12, as amended, and all applicable attachments thereto, and take all necessary measures to bring the establishment into compliance with the requirements of such Emergency Orders; and (2) submitting a fully executed attestation under penalty of perjury by the owner, general manager, or chief executive officer of the establishment, in the form attached hereto, to the County by email to reopening@broward.org, attesting that the review has been completed and the required measures have been taken, and receipt of County's acknowledgment of a valid executed attestation form. In addition, the establishment shall, within five (5) calendar days after reopening, submit to inspection and be inspected by local code enforcement

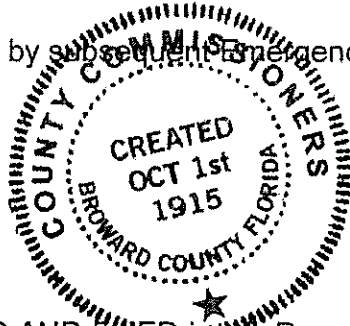
or law enforcement authorities to confirm the violation has been corrected. Any repeat violation by the establishment cited by the applicable code enforcement or law enforcement authority shall be presumed a knowing violation subject to a fine of up to fifteen thousand dollars (\$15,000) under Section 8-56(b)(2).

Section 2. Applicability; Severability.


This Emergency Order supersedes and replaces any contrary provision in any prior Broward County Emergency Order. Except as superseded, all Broward County Emergency Orders remain in full force and effect. This Emergency Order applies to incorporated and unincorporated areas within Broward County, but has no application outside of Broward County. The provisions of this Emergency Order shall serve as minimum standards, and municipalities within Broward County may establish more stringent standards within their jurisdictions, to the extent permitted by law. Any provision(s) within this Emergency Order that (i) conflict(s) with any state or federal law or constitutional provision, or (ii) conflict(s) with or are superseded by a current or subsequently-issued Executive Order of the Governor or the President of the United States solely to the extent such Executive Order (a) expressly preempts the substance of this Emergency Order or (b) imposes stricter closures than set forth herein, shall be deemed inapplicable and deemed to be severed from this Emergency Order, with the remainder of the Emergency Order remaining intact and in full force and effect. To the extent application of some or all of the provisions of this Emergency Order is prohibited on the sovereign land of a federally or state recognized sovereign Indian tribe, such application is expressly excluded from this Emergency Order.

Section 3. Effective Date; Duration.

This order shall be effective as of 12:01 a.m. on Friday, June 26, 2020. This Emergency Order shall expire upon the expiration of the existing State of Local Emergency, as same may be extended by subsequent order or declaration, unless earlier terminated by subsequent Emergency Order.
