## CITY OF WILTON MANORS

### EMERGENCY ORDER 2020-006

**WHEREAS**, on March 9, 2020, Governor Ron DeSantis signed Executive Order No. 20-52, thereby declaring a public health emergency in the State of Florida due to public health threat resulting from the spread of the Novel Coronavirus Disease 2019 (“COVID-19”); and

**WHEREAS**, on March 10, 2020, Broward County Administrator Bertha Henry declared a state of emergency in Broward County; and

**WHEREAS**, on March 11, 2020, the World Health Organization declared the COVID-19 outbreak a global pandemic; and

**WHEREAS**, on March 12, 2020, Vice Mayor Tom Green declared a state of emergency in the City of Wilton Manors at the request of City Manager Leigh Ann Henderson; and

**WHEREAS**, on March 17, 2020, the City Commission issued Emergency Order 2020-001 which, among other things, delegated to City Manager Leigh Ann Henderson the authority to issue further emergency orders until April 30, 2020; and

**WHEREAS**, the City Commission of the City of Wilton Manors met on April 28<sup>th</sup> and passed a motion to extend the delegation of authority to the City Manager until May 31, 2020; and

**WHEREAS**, Pursuant to the City Charter, Section 252.46, *Florida Statutes*, Chapter 19 of the City’s code of ordinances, the delegation of authority from the City Commission, and all other applicable laws, the City Manager has the authority to issue emergency orders with the force of law.

## IT IS HEREBY ORDERED:

Emergency Order 2020-01 is amended as provided herein, with strikethrough text indicating deletions and underlined text indicating additions:

1. The City Manager of the City of Wilton Manors, or the City Manager's designee (collectively "City Manager"), is authorized to issue further emergency orders as deemed necessary to protect life, liberty, and property by this emergency. Prior to issuing an emergency order, the City Manager shall consult with the Vice Mayor and Members of the City Commission. In the event that two or more Members (including the Vice Mayor and the Members of the Commission) object to the issuance of the emergency order, the emergency order shall not be issued without approval of a majority of the City Commission. This authority of the City Manager set forth in this paragraph 1 shall expire on ~~April 30, 2020~~ May 31, 2020, unless extended by action of the City Commission.
2. ~~All restaurants, bars, bowling alleys, gyms, and other facilities that can host a gathering within the City of Wilton Manors shall limit their building occupancy to fifty percent (50%), or fifty (50) patrons, whichever is less.~~
3. ~~All dine in restaurants, bars, bowling alleys, gyms, and facilities that can host a gathering within the City of Wilton Manors, shall close no later than 10:00p.m. Notwithstanding the foregoing, dine in restaurants are not prohibited from offering take out and delivery service.~~
4. ~~To the extent of any conflict between the terms of this Emergency Order and the terms of Emergency Order Number 20-68 (or the terms of any other Executive Order issued by the Governor of Florida), the terms of the Executive Order(s) issue by the Governor prevail. (Executive Order Number 20-6, among other matters, suspended the sale of alcoholic beverages after 5:00p.m. on March 17, 2020, requires restaurants to limit its occupancy to fifty percent (50%) of its current building occupancy and requires restaurants to follow the CDC guidance "by ensuring, at minimum, a 6-foot distance between any group of patrons and limited parties to no more than 10 individuals").~~
5. ~~All businesses in the City of Wilton Manors shall make hand sanitizer available to their customers and employees.~~
6. Code enforcement fines will not accrue during this state of emergency.
