#### **EMERGENCY ORDER 2020-010**

WHEREAS, on March 9, 2020, Governor Ron DeSantis signed Executive Order No. 20-52, thereby declaring a public health emergency in the State of Florida due to public health threat resulting from the spread of the Novel Coronavirus Disease 2019 ("COVID-19"); and

**WHEREAS**, on March 10, 2020, Broward County Administrator Bertha Henry declared a state of emergency in Broward County; and

WHEREAS, on March 11, 2020, the World Health Organization declared the COVID-19 outbreak a global pandemic; and

WHEREAS, on March 12, 2020, Vice Mayor Tom Green declared a state of emergency in the City of Wilton Manors at the request of City Manager Leigh Ann Henderson; and

WHEREAS, on March 17, 2020, the City Commission issued Emergency Order 2020-001 which, among other things, delegated to City Manager Leigh Ann Henderson the authority to issue further emergency orders until April 30, 2020; and

WHEREAS, the City Commission of the City of Wilton Manors met on April 28<sup>th</sup> and passed a motion to extend the delegation of authority to the City Manager until May 31, 2020; and

WHEREAS, the City Commission of the City of Wilton Manors met on May 26th and passed a motion to extend the delegation of authority to the City Manager until the Governor's State of Emergency expires or is terminated; and

WHEREAS, Pursuant to the City Charter, Section 252.46, *Florida Statutes*, Chapter 19 of the City's code of ordinances, the delegation of authority from the City Commission, and all

#### IT IS HEREBY ORDERDERED:

Section 1 of Emergency Order 2020-01, as amended by Emergency Order 2020-06, is amended as provided herein, with strikethrough text indicating deletions and underlined text indicating additions:

- 1. The City Manager of the City of Wilton Manors, or the City Manager's designee (collectively "City Manager"), is authorized to issue further emergency orders as deemed necessary to protect life, liberty, and property by this emergency. Prior to issuing an emergency order, the City Manager shall consult with the Vice Mayor and Members of the City Commission. In the event that two or more Members (including the Vice Mayor and the Members of the Commission) object to the issuance of the emergency order, the emergency order shall notbe issued without approval of a majority of the City Commission. This authority of the City Manager set forth in this paragraph 1 shall expire on May 31, 2020, when the Governor's State of Emergency expires or is terminated unless extended by action of the City Commission.
- 2. All other provisions of Emergency Order 2020-01 are hereby raitified and remain in full force and effect.
